## 4. The Future of the Society

President Erik Henriksen informed those present that he and Ron Smith had met with Brian Farquhar, Parks Manager on June 10<sup>th</sup> regarding the possibility of returning the heritage site to the Cowichan Valley Regional District. It was pointed out that the CVRD had the first rights should there be a change of ownership/management of the site which includes the Fairbridge Chapel and adjacent school house.

The reason for the discussion was because of the very low membership in the society (only 16 now) and fact that many of the members, including the Board of Directors were all aged in their mid 60's to mid 80's now.

The President mentioned that indeed the CVRD may look favourably to the idea. Mr. Farquhar outlined some possibilities for its continued management which mentioning what was being done to assist other organizations in the Cowichan Valley.

Mr. Farquhar felt we should first contact Area E Board Director, Alison Nicholson to see if she would be in favour of this proposal and explain to her the importance of the heritage site and reasons for the Society approaching the CVRD at this time.

That the President or Secretary arrange a meeting with Alison Nicholson to further explore the options for the CVRD to once again acquire the heritage site.
